PROJECT SUPPORT POSITION IN SOCLIMPACT PROJECT (“DOWNSCALING CLIMATE IMPACTS AND DECARBONISATION PATHWAYS IN EU ISLANDS, AND ENHANCING SOCIOECONOMIC AND NON-MARKET EVALUATION OF CLIMATE CHANGE FOR EUROPE, FOR 2050 AND BEYOND”), FUNDED BY THE HORIZON 2020 PROGRAM (SC5-06-2016-2017, GRANT AGREEMENT Nº 776661) FOR THE PERIOD 2017-2020.

The University of Las Palmas de Gran Canaria (ULPGC), Spain wishes to appoint 1 Project Support contract to work in the EU Project SOCLIMPACT during 35 months.

The SOCLIMPACT project (“Downscaling Climate Impacts and Decarbonisation Pathways In Eu Islands, And Enhancing Socioeconomic and Non-Market Evaluation Of Climate Change For Europe, For 2050 And Beyond”), funded by the Horizon 2020, aims at modelling and assessing downscaled CC impacts and low carbon transition pathways in European islands and archipelagos for 2050 - 2100, complementing current available projections for Europe, and nourishing actual economic models with non-market assessment.

The University will recruit the best candidate following the recommendations of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers. The job offer will be published through a wide range of portals. The evaluation of candidates and their selection criteria will be aligned with the equal opportunities policies of the ULPGC. Selection and hiring procedures will follow transparent mechanisms attending national and regional legislation.

The selection committee will be composed by Mr. Antonio Marcelino Santana González (General Manager of Fundación Canaria Parque Científico y Tecnológico at the ULPGC), Ms. Almudena Suárez (who will act as secretary of the commission), Prof. Carmelo León González (SOCLIMPACT coordinator at ULPGC, who will act as President of the Commission) and Ms. Yen E. Lam González (researcher of SOCLIMPACT project).

PREREQUISITES

The candidates must comply the following conditions:

1. Nationality:
 - a. Spanish nationality or that of one of the other member states of the European Union.
 - b. Whatever his nationality, spouses of Spaniards and nationals of other Member States of the European Union.
 - c. People included into International Agreements concluded by the European Union and ratified by Spain, related to free movement of workers.
 - d. Foreign candidates not included in paragraphs above, legally resident in Spain.



2. Age: Be over eighteen.
3. Degrees: postgraduate degree (master's degree) in one of the following fields: Communication, International Relations and / or Project Management. Applicants with qualifications obtained abroad, must prove that they are in possession of the corresponding validation or credential accrediting, where appropriate, the homologation.
4. Language: Demonstrate a good level of English, French and Spanish (min. level B1).
5. Experience: minimum 2 years experience in technical assistance and consultancy in projects funded by the European Commission.

WORKING CONDITIONS

This temporary contract is for specified work and services for the execution of SOCLIMPACT project in the Foundation Canary Scientific and Technology Park of the University of Las Palmas de Gran Canaria.

More specifically the tasks to be performed will be:

- Administrative and technical support for the project.
- Organization of regular meetings related to the project.
- Communication and coordination tasks between the partners of the consortium.
- Communication tasks and maintainance regular contact with the European Commission.
- Communication and coordination tasks with the TIDES team linked to the project.
- Updating and administration of the documentation and deliverables generated in the project.
- Invoicing tasks (accounting of the project, administrative tasks, invoicing) and supervision of the budgetary and accounting management of the project.
- Translation tasks related to the project.
- Preparation of the technical progress reports and deliverables for the EU.
- Support on the preparation of the financial reports of the project in accordance with EC financial rules.

The contract will conclude in case of funding shortfall. The position is suitable for a part-time employment. Gross salary: 1.000 €/month.

The start of the contract is estimated by January 1st 2018, and the duration is 35 months. The person hired will work for the SOCLIMPACT Project at the Institute of Tourism and Sustainable Economic Development (TIDES), in the University of Las Palmas de Gran Canaria, Canary Islands, Spain.

EVALUATION

The following items and scores will be taken into account in order to evaluate the CV submitted:

1.- Working experience (Max. 5 points):

- Experience in writing European proposals that have been funded by the EC in their 2014-2020 Programmes (H2020, Interreg, Erasmus+, Life y Cosme): 0,5 points per project submitted and financed. Max. 2 points.
- Experience in technical assistance in EC funded projects in their 2014-2020 Programmes (H2020, Interreg, Erasmus+, Life y Cosme): 0,2 points per project. Max. 1 point.
- Technical participation in Research and Innovation European Projects related to climate change, environment, technology, tourism and Enterprise in the context of the EC 2014-2020 Programmes: 0,2 points per project. Max. 1 point.
- Experience in administrative and financial tasks in R&D european projects and European educational projects in the context of the EC 2014-2020 Programmes 0,2 points per month worked. Max. 1 point.

2.- Further training (Max. 2 points):

- Training courses on European Funds, accounting software, database (0.25 points per course of a minimum of 20 hours. Max. 1 point).



- Attendance at conferences, seminars, workshops or conferences related to the subject of this contract (0.25 points per event. Max. 1 point).

3.- Language skills (Max. 1.5 points):

- English Level higher than B1: 0,3 puntos.
- French Level higher than B1: 0,3 puntos.
- Spanish Level higher than B1: 0,3 puntos.
- German Level higher than A1: 0,3 puntos.
- Italian Level higher than A1: 0,3 puntos.

4.- Interview (Max. 10 points)

The evaluation commission has the right to propose no candidate to this contract if it is found that no one fulfills the necessary experience to participate in this project.
